**DECLARATION OF MELINDA R. COOLIDGE  
IN SUPPORT OF PLAINTIFF’S MOTION FOR AN  
AWARD OF ATTORNEYS’ FEES AND LITIGATION EXPENSES**

I, Melinda R. Coolidge, declare as follows:

1. I am a partner with Hausfeld LLP. I submit this declaration in support of Plaintiff’s motion for an award of attorneys’ fees and expenses in connection with the services rendered, and costs and expenses incurred, in *Hartig Drug Co. Inc. v. Senju Pharm. Co.* (the “Action”).


2. For the period starting from the inception of the Action through and including July 31, 2018, the total number of hours spent by my firm working on the Action was **978.4**, with a corresponding lodestar of **\$625,116.00** based on current hourly rates. In connection with representing the Plaintiff in the Action my firm did the following: drafted the complaint, drafted responses to the defendants’ motions to dismiss, litigated the motions to dismiss to a successful reversal in the Third Circuit, negotiated, obtained, and reviewed the lengthy record of a prior related case, including numerous documents and depositions, as well as sales and pricing data, consulted with an economic expert to estimate damages incurred by class members, and successfully presented the evidence and damages estimates to defendants and a mediator, which

resulted in a settlement agreement. The lodestar amount was performed by attorneys and professional staff at my firm for the benefit of the Class. The hourly rates for the attorneys and professional staff in my firm are the usual and customary hourly rates charged by my firm in similar matters.

3. My firm has incurred a total of **\$82,925.63** in unreimbursed costs and expenses in connection with the prosecution of the Action from inception through and including July 31, 2018. The majority of costs incurred were for expert fees and expenses related to the successful mediation that resulted in settlement. These costs are reflected on the books and records of my firm. They were incurred on behalf of Plaintiff by my firm and have not been reimbursed.

I declare under penalty of perjury under the laws of the United States that the foregoing is true and correct.
