**STIPULATION AND [PROPOSED] ORDER  
REGARDING NOTICE AND CLAIMS DEADLINES**

WHEREAS, on January 17, 2018, Plaintiff Hartig Drug Company Inc. (“Hartig”) reached a settlement with Senju Pharmaceutical Co. Ltd. (“Senju”), Kyorin Pharmaceutical Co., Ltd. (“Kyorin”), and Allergan, Inc. (“Allergan,” and with Senju and Kyorin, “Defendants”) that resolved all claims in this matter;

WHEREAS, the Court preliminarily approved the settlement on February 27, 2018 (D.I. 56);

WHEREAS, on May 3, 2018, the Court issued an Order (the “May 3 Order,” D.I. 61) granting Plaintiff’s unopposed motion to distribute notice to the Class that set a deadline of July 3, 2018 to issue notice;

WHEREAS, after entry of the May 3 Order, Plaintiff learned that one of the publications

in which Publication Notice will be made, *Pharmacy Purchasing & Products*, cannot publish notice until July 9, 2018; and

WHEREAS, the notices as approved by the Court require a deadline by which the Settlement Class members must submit their claims (the “Claims Deadline”), and the parties believe that thirty-five (35) days before the Final Fairness Hearing, which is the same date by which any Settlement Class member must either opt out or object, is a logical date for the Claims Deadline;

IT IS THEREFORE STIPULATED AND AGREED, by and between counsel for Hartig and Defendants, subject to approval of the Court, that:

1. The May 3 Order shall be, and hereby is modified to provide that Publication Notice in *Pharmacy Purchasing & Products* may be made on or about July 9, 2018.
2. Any member of the Settlement Class who does not request to be excluded therefrom must submit a claim form no later than thirty-five (35) days before the date of the Final Fairness Hearing in order to be considered for compensation from the Settlement Fund.
3. All other deadlines in the May 3 Order shall remain.


